We would like to remind you that the entry deadline (entry form + deposit), defined by the Executive Committee, is **1 February 2013**. This will enable the CSU (Universiade Supervision Committee) and CTI (International Technical Committee) to proceed with the team selection and the draw during the Head of Delegations' Meeting in Kazan from 3 to 7 April 2013. The team draw for Beach Volleyball will be conducted along with the 1<sup>st</sup> General Technical Meeting in July 2013.
